2.0 Meeting Notes - May 15, 2024

Welcome, Introductions, and Agenda

Danny Shopf, Cambridge Systematics (CS), welcomed participants to the Florida Occupant Protection Coalition (FOPC) meeting and thanked everyone for joining. He facilitated a round of introductions, gave an overview of the agenda, and the meeting followed.

FOPC Strategic Action Plan Subcommittee Breakout

Coalition members split into subcommittee groups organized around each goal of the Strategic Action Plan. The subcommittee groups are organized around three goals:

- Enforcement
- Child Passenger Safety (CPS)
- Occupant Protection (OP) for Low Use Groups.

The subcommittee groups reviewed the action steps for their respective objectives. Each subcommittee will have a virtual check in meeting before the next coalition meeting.

CIOT Paid Media Presentation

Chris Craig, Florida Department of Transportation (FDOT), presented on the paid media activities for the Click It Or Ticket (CIOT) national enforcement and awareness campaign. He provided a timeline of the Memorial Day 2024 media and enforcement activities noting that paid media started on May 13th and will continue through June 2nd. The enforcement component will start on May 20th and continue through June 2nd. Chris emphasized that the Post CIOT awareness survey and the safety belt usage surveys will be conducted following the Memorial Day paid media and enforcement wave.

Next, Chris discussed the marketing strategy employed by the media vendor purchasing the advertisements in Florida's ten Designated Market Areas (DMAs) with an overall budget of \$1.5 million to reach the target audience of men ages 18-34. Chris then discussed the different mediums for the advertisements being purchased which included:

- 30 second spots on television and cable networks
- 30 second commercials on digital streaming applications
- 30 second video ads on Vizio smart TVs
- 30 second commercials on HULU
- 15 or 30 second video adds on YouTube
- 30 second video ads on Univision

Additional advertising spots included:



- 30 second radio spots
- 30 second audio on streaming services such as Spotify, Pandora, and Soundcloud.

Chris played examples of the radio and digital audio ads. He said additional video ads will be run on Facebook, Instagram, and Snapchat. Other types of advertisements included in the paid media strategy included billboards, vehicle wraps for transit vehicles, and gas station tv ads. Chris noted that Dynamic Messaging Signs (DMS) on the Florida Highway System will also be utilized to spread safety belt usage awareness. In total, the CIOT awareness campaign media investment is approximately \$1,500,000 for an estimated 30,608,818 impressions.

Chris emphasized the importance of the law enforcement partners participating in the enforcement component of the campaign. He noted that all agencies that receive subgrant funding are required to participate in the campaign. He said approximately 250 agencies participated last year and commended the efforts of the Law Enforcement Liaison (LEL) program for distributing educational and awareness materials for participating agencies to enhance their enforcement efforts.

Participants had the following questions and comments:

- Danielle Kessenger, Silver Linings Safety, asked if any ads were being run in movie theaters as part of the pre-roll prior to the film previews?
 - For pre-roll advertising, the national awareness campaigns would have priority for the ten minutes before previews, regional campaigns would have the preceding ten minutes, and the state campaigns would be slated for the ten-minute slot before the regional campaign. This means that state level campaigns would likely be playing thirty to twenty minutes before film previews start, which are already ten to fifteen minutes before the actual movie starts. There is also compelling market research that the target demographic of men ages 18-34 arrives right when the film is slated to begin. In many ways, state public information campaigns have almost completely stopped running ads in movie theaters.
- Danny asked if there was a difference in the cost of paid media this year due to the current election cycle.
 - It varies by media, the general trend is less time for higher cost, but the election cycle has not affected prices too dramatically yet, but that could change substantially in August.



Statewide Services and Support for Florida Child Passenger Safety Technicians and Instructors

Jasper Masciocchi and Patty Turner, University of Florida, (UF), presented on services provided through the Occupant Protection Resource Center (OPRC). Jasper reviewed the purpose, goals, objectives, and initiatives of the OPRC. She then discussed the programs and support services the OPRC provides. These programs and resources include:

- Resources for Diverse Safety Partners
- Child Passenger Safety Technicians/Instructors (PST/I) Education Support
- Child Passenger Safety (CPS) Outreach Support

The ORPC provides resources for a diverse set of safety partners through public education efforts and Jasper highlighted different examples for each type of partner. In reviewing the top five resources distributed over the past five years, Jasper emphasized that there were over 6,900 activity books and 3,750 bookmarks distributed totally overing 10,000 public education resources, many of which were available in Spanish and Creole. Additionally, the ORPC provides resources for CPST-I and law enforcement partners. Statewide services and support for Florida child passenger safety technicians and instructors included over 1,000 LATCH (Lower Anchors and Tethers for Child Restraints) manuals and 670 CPST student packages. Jasper noted that in Florida there are 1,356 CPS technicians, 88 instructors, and 2 instructor candidates. Additionally, the OPRC distributed 1,050 car seats with 180 car seats donated from the Florida Department of Highway Safety and Motor Vehicles (FLHSMV) from 2022-2023. Jasper noted that the CPS week is September 15-21, 2024, and that events associated with CPS week are eligible for car seat distribution as are CPST courses and events in other OP focus areas. The 2023-2024 FDOT Car Seat Focus Counties are as follows, counties where partners received car seats are denoted by an asterisk (*).

The OPRC also provides educational support to CPSTs and CPST-Is. As of May 2024, 210 scholarships had been awarded, with 52 percent of the scholarship funds going to technicians and instructors in the FDOT Car Seat Focus Counties. Another component of the educational support provided by the OPRC is the Instructor Stipend Program which provides teaching stipends for CPS instructors who teach certification courses. She reviewed the program, eligibility, and the stipend amounts. The 2023-2024 CPST Focus Counties are as follows:

The last component of the OPRC's CPST-I Educational Support Program is the enrichment course, Safe Travel for All Children (STAC) which the OPRC supports through course announcements, approvals, license fees, materials preparation, and instructor teaching stipends.

Additionally, the OPRC also provides CPS outreach support through National Digital Car Seat Form (NDCF) Training, CPS Fitting Stations tracking, and other statewide and community services. New initiatives pending FDOT approval include NDCF data entry training, biannual newsletters related to the NDCF dashboard, additional CPS courses and car seat checks, and a CPST-I survey to document and share best practices with CPS partners.

Participants had the following questions and comments:

- Amy Artuso, National Safety Council, applauded the OPRC's development and distribution of
 educational materials, noting that it's a higher standard of support than in other places. She also noted
 the significance of the NDCF data entry training and how that could be a model for other states.
- Zee Osuigwe, Santa Rosa County Development Services, praised the continuous improvement with the NDCF training.
- Wanda Tison, UF, asked what the OPRC can do to make reporting easier for CPS instructors and technicians and what ideas and recommendations they have for improving the OPRC educational and support services.
 - Petra Stanton, Johns Hopkins Children's Hospital, said that it's good for the OPRC to know that many CPS professionals are often away from their desks.



- Wanda thanked Petra for reminding participants of that fact and noted that instructors and technicians can also call the OPRC as opposed to using email.
- Zee suggested the development of a catalog of all materials to streamline the ordering process.
 - This is a good suggestion that will be realized once the Florida Traffic Safety Resource Center (FTSRC) is finalized and published online.
- Krista Ott, Gainesville Fire Rescue, commended the CPS fitting station mapping project since before that project there was not a way to track what was requested and what was received.
- Julie Noble, Golisano Children's Hospital-Safe Kids SWFL, thanked the OPRC team for being open to hearing and implementing the coalition's feedback.

Public Comment Period

There were no public comments.

Day 1 Recap

Danny provided a brief recap of Day 1, thanked everyone for their participation and reminded coalition members that Day 2 of the FOPC meeting would be at the Gainesville Police Department at 9 am.



3.0 Meeting Notes - May 16, 2024

Recap of Day 1

Danny welcomed participants and thanked everyone for attending Day 2 of the FOPC meeting. He gave a brief recap of Day 1, reviewed the Day 2 agenda, and the meeting followed.

Occupant Protection Model Language Review

Danny led the coalition through the latest drafts of the Occupant Protection Model Language documents that describe existing Florida Statutes (F.S.), their limitations, proposed changes, and justification for the proposed changes to F.S. 316.614 – Safety Belt Usage and F.S. 316.613 – Child Restraint Requirements.

The FOPC recommended changing the model language format so that the strikethrough and fonts do not hinder the readability of the document so that strikethrough is changed to red font, language that is added is green font, and modified language is yellow.

The FOPC agreed to the proposed changes to F.S. 316.614 and recommended the following changes:

- Change "seated position" to "seating position" throughout.
- Consult the Traffic Safety Resource Prosecutor for the last line of section (2), "as entered on July 17, 1984..." and consider changing "entered" to "amended."
- Under (2) Consider changing "car" to "motor vehicle" or "passenger vehicle" based on Federal Motor Vehicle Safety Standard 208.
- Under section (3) consider adding subsection (d) that defines seating position.
- Under section (5) strikethrough 18 years or older.

The FOPC agreed to the proposed changes to F.S. 316.613 and recommended the following changes

- Consider updating the statistics in the rationale section utilizing the following sources:
 - American Academy of Pediatrics Child Passenger Safety Policy Statement November 2018
 - American Academy of Pediatrics CPS webpage
 - American Association for the Surgery of Trauma Child Passenger Safety Recommendations
 - NHTSA's Car Seats and Booster Seats webpage



Legislative Updates

Danny provided an overview of recent legislative updates and opened the floor for coalition members to discuss items of interest that occurred during the 2024 Florida Legislative Session. The coalition noted that April is now Hot Car Prevention Month due to the passage of Ariya's law, SB 554 (2024). In addition to the designation, the law encourages Florida state agencies such as the Department of Children and Families, the Department of Health, the Department of Highway Safety and Motor Vehicles, as well as local governments, to sponsor events that promote public awareness of leaving a child unattended in a motor vehicle and methods to prevent hot car deaths of children. SB 690 - Prevention of Pediatric Vehicular Heatstroke which would have required motor vehicles be equipped with an alarm system that prompts the driver to inspect the vehicle for unattended occupants before exiting did not pass and died in the transportation committee. The coalition noted that there were not bills related to seat belts or child passenger safety introduced this legislative session despite often being introduced in previous years

Participants had the following questions and comments:

- Petra and Amy said that there is traction for a heat stroke coalition and task force starting in Florida
- Lelani Gruener, FLHSMV, noted that FLHSMV's legal analysis did not recommend passage of SB 690
 due to inconsistencies in the pricing of alarm systems, as well as the limited ability to maintain and
 monitor the alarm systems.
- Danielle Kessenger, noted that National Car Death Prevention Day is May 1st and asked if Texas and California have similar or different awareness campaigns. According to the <u>National Safety Council Hot Car Deaths Dashboard</u> Texas leads the nation in child heatstroke deaths in vehicles with 144 deaths since 1998. Florida follows with the second highest number of child heatstroke deaths in vehicles since 1998 at 111. California is third with 57 total child heatstroke deaths in vehicles since 1998.
- Rhonda Cerulli, Safe Kids Treasure Coast, noted that the awareness campaign may be considered an
 unfunded mandate that can stretch already overburdened event coordinators without providing
 additional resources.
 - Chris Craig noted that social media qualifies as awareness and said that the new law does not specify the level and extent of the awareness campaign so that agencies with limited capacity to take on new initiatives can still engage the public.
- Danielle Kessenger noted that the new hot death prevention task force could create a prestigious award that incentivizes agency participation. She also asked for a status update on the hot car tip card the coalition has been developing over the last several meetings.
 - Chris Craig said that the tip card is awaiting approvals from NHTSA and FDOT Communications before printing.



Florida Laws Vehicle Definitions

Nick Wollschlager, LEL, presented on the many vehicle definitions detailed in Florida's laws. He said he will be presenting this information on a quarterly basis throughout his LEL district and noted that the presentation will be provided and distributed to partner agencies as well. Nick noted that the presentation is due to feedback expressing confusion related to the numerous and sometimes conflicting statutes defining a motorcycle, an autocycle, electric bicycle, scooter, moped, or other micromobility device.

Action Plan Report Out

Danny led the coalition in the Action Plan Report out. Action Step leaders provided updates on their respective action steps. Updates are available in Appendix A.

Public Comment Period

There were no comments from the public.
