2.0 Meeting Notes - November 13, 2024

Welcome, Introductions, and Agenda

Danny Shopf, Cambridge Systematics (CS), welcomed participants to the Florida Occupant Protection Coalition (FOPC) meeting and thanked everyone for joining. He facilitated a round of introductions, gave an overview of the agenda, and the meeting followed.

FOPC Strategic Action Plan Subcommittee Breakout

Coalition members split into subcommittee groups organized around each goal of the Strategic Action Plan. The subcommittee groups are organized around three goals:

- Enforcement
- Child Passenger Safety (CPS)
 - Danny provided a brief explanation of a new approach to focus the Child Passenger Safety (CPS) subcommittee into two groups. The two groups were organized around the following Objectives:
 - Objective 3A: Expand, Improve, and Retain CPS Technicians and Instructors
 - Objective 3B: Expand CPS Digital and Print Resources and Materials, Objective 3C:
 Support Mandatory Diversion Programs for First-Time Child Restraint Offenders, and
 Objective 3D: Support Enhancement of Florida's CPS Laws and Policies.
- Occupant Protection for Low Use Groups

The subcommittee groups reviewed the action steps for their respective objectives. Each subcommittee will have a virtual check in meeting before the next coalition meeting.

Occupant Protection Model Language Finalization

Danny displayed draft model language developed by the FOPC during the past several meetings. The two draft model languages were developed for **F.S. 316.613 Child Restraint Requirements** and **F.S. 316.614 Safety Belt Usage**. Coalition member's suggested changes are listed below:

- A coalition member asked for someone with law enforcement background to confirm that the phrase "restraint device" is acceptable.
 - Since "restraint device" is present in the existing statute, it is acceptable from a law enforcement perspective. Law enforcement officers are unlikely to verify manufacturer specifications in the context of a traffic stop.
- The coalition recommended adding specific references to federal law in 316.613 (1)(a) instead of "federally approved."



• The coalition suggested to make the inclusion of the Motor Vehicle Safety Standard consistent between F.S. 316.613 and F.S. 316.614.

The coalition agreed on the final changes discussed above. Danny noted that once implemented, the model language will be made available on the FOPC website.

CPS Materials Finalization

Chris Craig, Florida Department of Transportation (FDOT), directed the coalition's attention to the CPS materials that the coalition has been developing over the past several meetings. He noted that the Children in Hot Cars tip card is finalized and printed, with copies available around the room. Then Chris said that the CPS Coloring Book is almost complete, but that one page needs to be switched out for a page with additional content. Danielle Kessenger, Silver Linings Safety, volunteered to draft a new page for the coloring book. She said she will share her draft with the coalition soon. Chris introduced Jason Rogers, University of Florida (UF), who is overseeing the Child Fitting Station Locator Mapping project. Jason and Chris displayed the tip card for the Child Fitting Station Locator website and asked coalition members for their feedback, which is documented below:

- Amy Artuso, National Safety Council, asked if there was capability to add a link that navigates the user to a website with a virtual car seat check option?
 - Jason said that there is capability to add a singular URL address.
 - o Amy recommended a link to add to the tip card.
 - Chris said to add a section to the tip card that says "if there are no fitting stations near you, go
 to the to the appropriate website. More information can be found at <u>FDOT Safety Office</u>
 Occupant Protection and Child Passenger Safety Programs.
- Danielle Kessenger suggested a landing page or splash screen that describes how to use the site that must be cleared to proceed to the site.

2024 Occupant Protection Fact Sheet Update

Alan Amidon, CS, presented the 2024 update to the Occupant Protection (OP) Fact Sheet. The fact sheet summarizes key data attributes derived from the Florida Highway Safety and Motor Vehicles (FLSHM) yearly crash closeout. The fact sheet is intended for a general audience to stay informed on the Occupant Protection challenge in Florida. Alan noted that in 2022, 877 people who died and 1,991 who were seriously injured on Florida's roadways were not wearing a safety belt. Additionally, the 2024 Florida Safety Belt Use Observational Survey indicated that Florida's statewide safety belt usage rate was 90 percent, increasing from 89.4 percent the previous year. The 2024 Child Restraint Observational Survey indicated that 82 percent of children, ages 0-12, were restrained across the state of Florida. The trends section of the OP Fact Sheet provides an overview of unrestrained occupant fatalities and serious injuries by gender, month of the year, day of week, time of day, age, community type, Florida residency, and by seating position. Overall, young male Florida residents driving at night and on weekends in urban areas continue to be those most likely to be involved in fatal and serious injury crashes where a restraint system is not used.

Participants had the following questions and comments:



- Do we need to define serious injury?
 - No, we reference FLHSMV as the data source and information on how that is defined can be found there.
- Consider adding a shadow to the serious injury by Florida resident pie chart for consistency.
- Check spelling in seating position graph.
- Consider changing the seating position graph. Rates are typically confusing to the public and the story isn't very compelling. Maybe a stacked bar or a pie chart with the fatalities and serious injuries on two separate graphs?
- Add a resources section and include links to other coalitions and relevant resources

Public Comment Period

There were no public comments.

Day 1 Recap

Danny provided a brief recap of Day 1, thanked everyone for their participation and reminded coalition members that Day 2 of the FOPC meeting would be held at the Gainesville Police Department starting at 9 am.



3.0 Meeting Notes - November 14, 2024

Recap of Day 1

Danny welcomed participants and thanked everyone for attending Day 2 of the FOPC meeting. He gave a brief recap of Day 1, reviewed the Day 2 agenda, and the meeting followed.

Post CIOT Awareness Survey Results

Andrew Hopkins, University of North Florida (UNF), presented on the Post Click It Or Ticket (CIOT) Awareness survey results administered by UNF's Public Opinion Research Lab (PORL). The survey is conducted after the yearly awareness campaign to evaluate the effectiveness of FDOT's messaging.

The demographic profile of the survey respondents consisted of a sample size of 1,699 adult age Florida residents that were further segmented by age, race/ethnicity, and gender. He discussed the sampling methodology for the survey before discussing the survey findings. Overall, CIOT awareness increased 11 percentage points from 68 percent in 2022 to 79 percent in 2024. The highest year of awareness, however, was in 2017 with 86 percent awareness. Of the 11 media markets surveyed, the Tallahassee area had the highest awareness with 90 percent of respondents indicating engaging with CIOT content and the Panma City market area having the lowest awareness. Additionally, men and women reported similar awareness, the age category of 35-54 had the greatest awareness by age, and Hispanic and Latino respondents indicated an increase in awareness from 66 percent to 77 percent from the previous year.

The survey also polled respondents ages 18-34 asking how often members of this age group wear their safety belt when driving. Overall, the percentage of 18-34 year olds that indicated that they wear their safety belt all the time has decreased six percentage points since 2015. Similarly, pickup truck drivers indicated a historically low percentage of respondents who report using their seat belt all the time, declining four percentage points from 85 percent in 2023 to 81 percent in 2024.

The survey also asked respondents, in an open-ended manner, about the most effective ways to encourage safety belt use. Education and graphic images continue to be the most popular response across all project years with 38 percent indicating this as the most effective way of encouraging awareness. Additionally, respondents were asked if they would support safety belt warning systems for all passengers not buckling up and if they would support a law requiring all passengers in the vehicle to be buckled. Survey respondents indicated overwhelmingly support with 91 and 90 percent support, respectively.

Lastly, Andrew compared the awareness of respondents located in counties identified by the FDOT Highway Safety Matrix across each population grouping of counties. He emphasized that the Group III counties with populations under 50,000 indicated less safety belt usage and less support for laws requiring all passengers to be belted.

Participants had the following questions and comments:

• Mike Zinn, FDOT District 7, asked how do the surveyors know what type of media or engagement material the respondents see?



- Andrew said that the survey asks that question directly with response methods including over the phone, online, text messages, as well as follow up emails. He noted that the survey team takes multiple approaches to communicate with and cover the identified target audience.
- Amy asked if in the choices to the question of where respondents saw CIOT media does the cable TV selection include cord-cutting households that only stream content?
 - o Andrew said that streaming is a separate answer that respondents can identify.
- Mike asked what changes the behavior of 18-34 year olds?
 - Andrew emphasized that the survey is not intended to and does not speak to driver behavior, but does indicate what survey respondents would consider to be effective strategies for increasing awareness of the CIOT message.
 - Mike asked for clarification on the meaning of graphic images.
 - Andrew said graphic images refer to images of crashes that demonstrate the risk and deadliness of being in a vehicle unbuckled. He said that survey does not delve into what low use groups would find the most effective increasing awareness.

Model Policy for State Agencies and Florida Businesses

Willem de Greef, FDOT, displayed a draft model safety belt policy for state agencies and Florida businesses, and asked for participants' feedback on the policy. He noted the policy is intended to be a premade solution to give to organizations to require employees whose jobs include driving or travel to wear safety belts during work hours. Participants feedback is documented below:

- Add "or denied" "worker's compensation benefits may be reduced."
- Reference FS 316.613 and incorporate child restraint systems.
- Consider developing three separate draft policies. One focusing on safety belts, another focusing on car seats, and another that combines the two.
- Change "accident" to "crash" throughout.
- Delete "any additional" before manufacturer guidelines.
- Consider making a bulleted version of the policy to enhance readability.
- Consider adding "termination" to disciplinary action section.

Participants had the following questions and comments:

- Mark Solomon, Preusser Research, asked for clarification on the goal of this policy. Is this intended to incentivize employers to follow the law?
 - Danny indicated that this could be a tool to align with national best practices until Florida law changes to include all passengers regardless of age.



- Mike emphasized that employers could receive a reduction in insurance costs for adopting this policy.
- Danielle Kessenger asked if the policy would include use of ride share companies?
 - Willem indicated that this is intended for state/company owned vehicles or vehicles leased by employers for job duties.
- Rhonda Cerulli, Florida Department of Health (FDOH), emphasized that FDOH requires employees transporting children as part of their job to be certified as a CPS technician.
 - Amy noted that organizations can edit the policy so it is applicable to their context. She said there could be two formats, one that is comprehensive and one that organizations can edit.
- Danielle Kessenger asked how other coalitions function in developing similar materials?
 - Chris Craig noted that it varies by coalition, emphasized that many active members on other coalitions do extensive work outside of the quarterly coalition meetings and recommended the formation of a subcommittee to continue the development of the model policy.

FDOT Fiscal Year 2024-2025 Occupant Protection and Child Passenger Safety Subgrants

Chris Craig presented on the Occupant Protection and Child Passenger Safety projects awarded subgrant funding through the approval of the Annual Grant Application for Fiscal Year 2024-2025. He said that the FY25 AGA consists of approximately 264 projects across \$45 million in subgrant funding.

Chris gave an overview of fatal and serious injury crashes in Florida and those specific to OP. He said that FLHSMV has finalized crash data for 2022 and that 3,556 fatal and 16,003 serious injury crashes occurred on Florida's roadways across all emphasis areas. He noted that while 2023 data is preliminary, there appears to be a slight decrease with 3,431 fatal and 15,347 serious injury crashes. Additionally, 773 fatal and 1,605 serious injury crashes involved at least one unrestrained occupant in 2022. Similar to the statewide decrease, there were 692 fatal and 1,539 serious injury crashes involving at leas one unrestrained occupant in 2023. Chris noted that 22 percent of Florida's total fatalities involve unrestrained drivers and passengers. Additionally, unrestrained drivers and passengers make up 40 percent of fatal crashes to people in motor vehicles.

The FDOT State Safety Office administers subgrant funding for occupant protection and child passenger safety projects in the following areas:

- High Visibility Overtime Enforcement
- Statewide Click It Or Ticket Enforcement and Media Campaign
- Statewide Safety Belt, Child Passenger Safety, and Post Click It Or Ticket Awareness Surveys
- Child Passenger Safety Resources and Support
- Florida Occupant Protection Coalition



- Child Passenger Safety Fitting Station Database and Mapping
- Child Passenger Safety Support
- Child Passenger Diversion Program

Chris discussed the subgrant funded projects listed above. He displayed the locations of the FY25 enforcement subgrants and noted that \$2,200,000 in total funding is being administered to local agency partners. Next he displayed counties identified by the Highway Safety Matrix to be in the top 40 percent of counties with the most fatal and serious injury crashes involving unrestrained occupants that do not have agencies receiving subgrant funding. He encouraged participants to reach out to contacts in the identified locations and encourage them to develop and submit concept papers by the end of February. He closed his presentation by listing what FDOT can and cannot provide through a subgrant and opened the floor for questions.

Participants had the following questions and comments:

- Jacob Gonzalez, Tampa Police Department, noted that his agency does not have a law enforcement
 unit that focuses on safety belt enforcement. The subgrant funding makes it possible for a unit to be
 focused on safety belt enforcement throughout the entire year, in addition to the statewide CIOT
 campaign.
- Amy noted that it would be helpful to connect the dots between the enforcement and diversion programs.
- Jacob emphasized that the OP grant enables Law Enforcement Agencies to participate in Child Passenger Safety.
 - Amy asked if Jacob's agency is leading CPS courses where fines or points could potentially be reduced?
 - Jacob said that his agency takes the approach of a fix-it-ticket where if someone fixes what a Law Enforcement Officer (LEO) pulled them over for, then citation is dismissed.
 - That approach could be done for CPS violations in the future if demonstrated to be effective.
- Mike asked if agencies could continue to use the message boards provided through subgrant funding?
 - Agencies are required to utilize message boards provided with OP subgrant funding to display
 OP messages for the first year.
- Mike asked if other first responder agencies such as fire departments can apply for subgrant funding?
 He noted that he has heard of fire departments being interested in message boards.
 - Chris emphasized that similar to LEA's that ask for only equipment that there must be an educational or enforcement component.



- Mike asked if a fire department concept paper that does Child Passenger Safety education and engagement and asks for OP message boards would be approved?
- Chris said it would be dependent on the specifics of the concept paper, the problem identification, and countermeasure strategy as the subgrants administered through FDOT are focused on reducing fatalities and serious injuries on Florida's roadways.
- Amy asked about the process for the dynamic message boards.
 - Chris said it's a collaborative process with traffic operations and communications that must be approved at the federal level.
 - o Amy asked if there were any dynamic message board signs for preventing child heat stroke?
 - Chris said there may be some he is not aware of, but emphasized that the dynamic messaging boards focus is on highway travel with safety messaging as a secondary priority.



Action Plan Report Out

Danny led the coalition in the Action Plan Report out. Action Step leaders provided updates on their respective action steps. Updates are available in Appendix A.
